NOTES:

1 The current balance of the Meetinghouse Trust Fund is \$16,137.03 (as of 9/30/30312). This fund is added to at each Town Meeting, usually by \$3,000.

2 The current balance of the Town Clocks Trust Fund is \$6,574.29 (as of 9/30/30312). This fund has not been added to in recent years. Maintenance of the two Town Clocks is paid for from this fund. A portion of the project cost devoted to the renewal of the clock faces will be covered by this fund.

3 The current balance of the Municipal Buildings Trust Fund is \$427,063.29 (as of 9/30/30312). All costs over and above the amount raised, as above, will be covered by this fund.

I have accessed all the BofS Minutes to see that all the donations have been accepted. The ones I can't find are: \$663 from the JHDC Trust. It would have been a check from Charter Trust (see attachment). And a \$200 check from LCHIP received as an Incentive Payment. Would these two have to have been accepted by the BofS? If not, do you have images of the checks that can be sent to me?

Also, the BofS Minutes of January 11, 2021 show a \$100 donation from Marc Tieger. I have no record of this. Presumably it went directly to the Town Office and not to or through me. Can you confirm that this was received? Any chance of an image of the check?

Lastly, does the Town have a specific account to which all these donations were deposited? If so, what is the name of the account and can some sort of printout be run and sent me that shows the donations and the total?
